May kindly see the property statement submitted online dated 06.05.2020 received from Sri Balwant Kumar Bharati, Judicial Magistrate, Mau regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial year 2017-18 & 2018-19, income from salary is Rs.20,47,505/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, Car loan, LIC policies and the balance of his savings bank account(s) is enhanced for Rs.26,466/- this financial year from previous year's balance, total of which is Rs.6,42,190/-. Thus, a sum of Rs.14,05,315/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

In this connection, it is submitted that Sri Balwant Kumar Bharati has already submitted his property statement at the time of joining into judicial service which had already been processed online and submitted before Hon'ble Mr. Justice Surya Prakash Kesarwani, Administrative Judge, Mau for kind perusal and orders (online on case-id no. 962).

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 vide online dated 06.05.2020. As such, there is delay in submitting the same from the part of the officer for which he has stated that before joining the Judicial Service on 10.02.2017 as Civil Judge (Jr. Div.), Mau, he was

posted as Assistant Registrar, Cestat New Delhi and the related documents & details of Bank could not received by him in time and much delay was caused in it due to which he could not submit the siad statement within time in his enclosed clarification dated 22.07.2020.

May, therefore, if approved, property statements of the financial year 2017-18 & 2018-19 of Sri Balwant Kumar Bharati, Judicial Magistrate, Mau be laid before Hon'ble Mr. Justice Surya Prakash Kesarwani, Administrative Judge, Mau Judgeship for His Lordship's kind perusal and orders?
