May kindly see the property statement submitted online dated 08.05.2020 received from Sri Mahendra Singh-IV, Additional District & Sessions Judge, Jaunpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2016-17 & 2017-18, total income is Rs.30,25,443/- (income from salary is Rs.29,99,443/-, withdrawal from Tax saving Bond of Rs.20,000/- and dress allowance of Rs.6,000/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, Income Tax, Home loan, car loan, Insurance policies and the balance of his savings bank account(s) is enhanced for Rs.94,846/- this financial year from previous year's balance, total of which is Rs.17,23,291/-. Thus, a sum of Rs.13,02,152/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2009-10 which had already been seen by Hon'ble Mr. Justice Arun Tandon, the then Administrative Judge, Lucknow in the misc. file of the officer. And of the financial years 2010-11 & 2011-12, 2012-13 & 2013-14 and 2014-15 & 2015-16 are currently processed & separate notes has made on case-id no. 943, 945 and 946 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements

of the financial years 2016-17 & 2017-18 vide online dated 08.05.2020. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial years 2016-17 & 2017-18 of Sri Mahendra Singh-IV, Additional District & Sessions Judge, Jaunpur be laid before Hon'ble Mr. Justice Om Prakash VII, Administrative Judge, Jaunpur Judgeship for His Lordship's kind perusal and orders?
