May kindly see the property statement submitted online dated 08.05.2020 received from Sri Mahendra Singh-IV, Additional District & Sessions Judge, Jaunpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2018-19 & 2019-20, total income is Rs.56,26,924/- (income from salary is Rs.55,59,974/- and LIC refund of Rs.66,950/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, Income Tax, Home loans, car loan, paid through a/c for purchase of house and Insurance policies are Rs.34,76,480/-. Thus, a sum of Rs.21,50,444/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.9,202/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2009-10 which had already been seen by Hon'ble Mr. Justice Arun Tandon, the then Administrative Judge, Lucknow in the misc. file of the officer. And of the financial years 2010-11 & 2011-12, 2012-13 & 2013-14, 2014-15 & 2015-16 and 2016-17 & 2017-18 are currently processed & separate notes has made on case-id no. 943, 945, 946 and 948 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements

of the financial years 2018-19 & 2019-20 vide online dated 08.05.2020. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2018-19 & 2019-20 of Sri Mahendra Singh-IV, Additional District & Sessions Judge, Jaunpur be laid before Hon'ble Mr. Justice Om Prakash VII, Administrative Judge, Jaunpur Judgeship for His Lordship's kind perusal and orders?
