

**Registrar (J)(Budget)**

May kindly see the online 12.05.2020 received from Sri Manish Kumar-I, Addl. District and Sessions Judge, Etah regarding submission of statements of movable and immovable properties for the financial years 2018-19 and 2019-20 on proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-19 and 2019-20 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial year 2018-19, his gross income from salary and other sources is Rs. 24,38,838/- (Rs. 20,78,838/- from salary, Rs. 1,10,000/- from sale of U.K. Liptis trees and Rs. 2,50,000/- from agriculture) and total deductions/Savings/investments against GIS, LIC, NPS, PPF, income tax and share is Rs. 19,29,069/- is (including enhancement of balance of Rs. 6,10,814/- in his saving bank A.cs against the balance of the previous year). Thus a sum of Rs.5,09,769/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2018-19.
2. In the financial year 2019-20, his gross income from salary and other sources is Rs. 19,52,931/- (Rs.17,02,931/- from salary and Rs. 2,50,000/- from agriculture) and total deductions/Savings/investments against GIS, LIC, NPS, PPF, Income Tax, and SIP is Rs. 6,38,682/-. Thus a sum of Rs. 13,14,249/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2019-20. The balance of Rs. 10,32,410/- has decreased from his saving bank A/c against the balance of the previous year.

It is pertinent to mention that the wife of the officer, Smt. Charanjeet Kaur, is an advocate whose annual income is Rs. 8,47,500/- in the F.Y. 2018-19 and Rs. 9,27,000/- in the F.Y. 2019-20.

In this connection it is submitted that the officer has already submitted his property statements upto the financial year 2017-18 which has already been seen by Hon'ble Dr. Justice K.J. Thaker, the then Administrative Judge, Etah in the in the Misc. file of the officer.

The movable and immovable property statement for the financial years 2018-19 and 2019-20 have been submitted by the Officer vide his online case id no. 965 dated 12.05.2020 which was due to be submitted upto the end of the financial year 2020-21. As such, there is no delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial years 2018-19 and 2019-20 of Sri Manish Kumar-I, Addl. District and Sessions Judge, Etah be laid before Hon'ble Mr. Justice Anjani Kumar Mishra, Administrative Judge, Etah Judgeship for His Lordship's kind perusal and orders?
