In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings

investment and expenditure made by him are given below.

(1) In the financial year 2018-19 & 2019-20, total income (both the financial years) is Rs.51,07,334/- [income from salary (including allowances) is Rs.50,09,614/-, Income Tax refund is Rs.5,720/- & received from maturity of LIC is Rs.92,000/-] and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, LIC, Mutual fund, SIP, PPF a/c and the balance of his savings bank account(s) is also enhanced for Rs.1,62,110/- this financial year from previous year's balance, total of which is Rs.40,83,493/-. Thus, a sum of Rs.10,23,841/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years 2018-19 & 2019-20.

It is pertinent to mention here that his wife is Advocate ,temporarily received from guest lecture is Rs.1,60,800/-.

In this connection it is submitted that for the preceding year, he has submitted his property statement upto the financial year 2017-18, which has already been seen by Hon'ble Mr. Justice Ved Prakash Vaish, the then Administrative Judge, Shahjahanpur in the mlsc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements

of the financial year 2018-19 & 2019-20 vide online dated 15.05.2020. As such, there is no delay in submitting the same from the part of the officer.
