May kindly see the property statement submitted online dated 27.10.2020 received from Sri Nyaydhish Pankaj, Civil Judge (Jr. Div.), Mau regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2016-17 (I,.e., from 16.01.2017 to 31.03.2017) & 2017-18, Total income from salary is Rs.9,96,264/- and total deductions/ repayment/savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Mutual funds, LIP and the balance of his savings bank account(s) is enhanced for Rs.27,437/- this financial year from previous year's balance, total of which is Rs.1,44,333/-. Thus, a sum of Rs.8,51,931/- was therefore available with him to meet out the household expenditure of himself in one year & 3 months of both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement at the time of joining into judicial service which has already been submitted online (in the e-service ID no.981) before Hon'ble Mr. Justice Surya Prakash Kesarwani, Administrative Judge, Mau for kind perusal & order.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 up to March 2019. He has submitted movable and immovable property statements for the financial years 2016-17 & 2017-18 firstly vide online dated 28.09.2020. As such, there is delay in submitting the same from the part of the officer for which he has stated that he could not get time to prepare his property statement for the relevant block year due to being pre-occupied in the training at JTRI Lucknow, and thereafter, being too busy in the discharge of judicial functions, he request the Hon'ble court to kindly accept his property statement and he further undertake to submit next statement when due in time in her reply dated 28.09.2020.
