

**Joint Registrar(J)(Budget)**

May kindly see the property statement submitted online dated 15.03.2021 received from Sri Pawan Kumar Singh, Additional Civil Judge (Sr. Div.)/ Additional Chief Judicial Magistrate, Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2017-18 & 2018-19, Gross income from salary (of both the financial years) are Rs.21,19,408/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Car loan, PPF, SIP, Insurance policy and the balance of his savings bank account(s) is enhanced for Rs.1,93,675/- this financial year from previous year's balance, total of which is Rs.10,65,262/-. Thus, a sum of Rs.10,54,146/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that his wife is Deputy Collector having annual income of Rs.9.19 lakh approx.

In this connection, it is submitted that the officer has already submitted his property statement at the time of joining into judicial service which had already been seen online by Hon'ble Mr. Justice Om Prakash VII, Administrative Judge, Varanasi in e-service ID no.975 and for the financial years 2015-16 & 2016-17, a detailed online office note be laid before Hon'ble Mr. Justice Om Prakash VII, Administrative Judge, Varanasi in e-service ID no.995 for kind perusal & orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years

2017-18 & 2018-19 in its next financial year i.e., 2019-20 up to March 2020. He has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 firstly vide online dated 08.06.2020. As such, there is delay in submitting the same from the part of the officer for which he is extremely sorry for the incessant delay in submission of property statement due to health reasons of his parents, who are in their old ages and further assures to be careful and punctual in future (mentioned in column no.9 of the movable statement).

May, therefore, if approved, property statements of the financial year 2017-18 & 2018-19 of Sri Pawan Kumar Singh, Additional Civil Judge (Sr. Div.)/ Additional Chief Judicial Magistrate, Varanasi be laid before Hon'ble Mr. Justice Om Prakash VII, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders?
