कृपया माननीय उच्च न्यायालय के उपरोक्त वर्णित पत्र का संदर्भ ग्रहण करने का कृपा करें जिसके माध्यम से उपनिबंधक महोदय द्वारा कतिपय बिन्दुओं पर स्थिति स्पष्ट करने हेतु निर्देशित किया गया है जो कि मेरे द्वारा दिनांक 08.01.2016 को माननीय न्यायालय को प्रेषित चल अचल सम्पत्ति के विवरण वर्ष 2010-11 ता 2014-15 के सम्बंध में है। इस सम्बंध में मेरा बिन्दुवार निम्न स्पष्टीकरण है:-

1. ए. यह कि उक्त संदर्भित पत्र में मेरी सकल वार्षिक आय वित्तीय वर्ष 2010-11 में रुपये 4,81,760/-रु. दर्शायी गयी है, जबकि मेरे द्वारा 3,78,857/-रु. स्टेट बैंक बचत खाते में जमा करने का उल्लेख उक्त पत्र में माननीय न्यायालय द्वारा अंकित किया गया है और माननीय न्यायालय ने उक्त पत्र में यह इंगित किया है कि मेरी समस्त कटौतियां व जमा धनराशियों के अनुसार कुल धनराशि-4,90,894/-रु. निकलकर आती है। इस प्रकार माननीय न्यायालय ने मुझसे यह स्पष्टीकरण चाहा है कि वित्तीय वर्ष 2010-11 में किस प्रकार से मैंने अपने परिवार का भरण पोषण किया। इस संबंध में वित्तीय वर्ष 2010-11 के साथ-साथ वित्तीय वर्ष 2009-10 में मेरे द्वारा प्रेषित चल अचल सम्पत्ति के विवरण पत्र का अवलोकन किया जाना आवश्यक है जिसमें कॉलम नं-5 में मेरे द्वारा स्टेट बैंक बचत खाते में दिनांक 31.03.2010 को बैलेंस धनराशि मु. 1,30,907/-रु. थी, जबकि वित्तीय वर्ष 2010-11 में दिनांक 31.03.2011 को शेष बैलेंस धनराशि 1,08,620/-रु. थी। इस प्रकार उक्त स्टेट बैंक खाते में धनराशि बढ़ने के स्थान पर घटाई है और इस खाते में 22,287/-रु. कम हुये हैं जो मेरे द्वारा अपने खर्च में लिये गये।

बी. यह कि वित्तीय वर्ष 2009-10 के चल अचल सम्पत्ति के विवरण पत्र में मेरे पी.एन.बी. बचत खाते में दिनांक 31.03.2010 को शेष बैलेंस धनराशि


