With reference to endt. nos.3628/I dated 5.12.17 and 1496/I dated 15.4.19 of the District Judge, Bulandshahr on the above subject, I have to say that Sri Sudhir Kumar-IV, Special Judge(U.P. Dacoity A.A.), Ramabai Nagar (Kanpur-Dehat) has submitted his property statements for the financial years from 2016-17, 2017-18 and 2018-19 but in the property statement for the financial year 2016-17, it has been found that Sri Sudhir Kumar income from Salary and other Sources is Rs. 16,33,708/- and from this amount he has deposited Rs.1440/- against GIS, Rs.3500/- against GPF, Rs.82,350/- against LIC's, Rs.246102/- against Income Tax, Rs.2,58,948/- reayment of loans and the balance of his Saving Bank account(s) enhanced for Rs.10,52,489/- (approx.) against the last year's balance. The total of which comes to Rs.16,44,829/- which is more than his Salary and similarly in the financial year 2017-18 his income from Salary and other Sources is Rs.16,91,925/- and his deductions/investment/payment of loan is Rs.16,38,021/- a very meager amount was left to him to maintain his family of four members. .

I am therefore to request you kindly to ask Sri Sudhir Kumar to clarify as he has managed his household expenses of four members family in the aforesaid financial years with the income of his wife or any other sources, to the Court at the earliest, so that further necessary steps may be taken in the matter.
