It is most respectfully submitted that the applicant has joined this service on 17-06-2006 as Judicial Magistrate, Firozabad. The applicant has submitted his property statement of at the time of joining the service and of the financial year 2006-2007, 2007-2008, 2008-2009 and 2009-2010, on 15-09-2010 vide letter no 3162/I dated 15.09.2010, when the applicant was posted at Ghaziabad as Add. Again the applicant has submitted his property statement (movable & immovable) of the financial year of 2006-2007, 2007-2008, 2008-2009, 2009-2010, 2010-2011 and 2011-2012 and of at the time of joining of service, by vide letter no 1445/I dated 10-06-2013, when the applicant was posted as add. chief metropolitan magistrate 9th Kanpur nagar. Again applicant has recieved the objection by Vide letter no 11262/IV-3249/Admin(IA) dated 16-08-2013 by The Hon'ble High Court.

Applicant has submmited his property statement of his movable & immovable propery of all the financial year till 2019-2020 in detail on the e-service portal on the website of Hon'ble High Court.

Sir, the applicant seeks unconditional apology for the late submission of his property statement. The reason behind such late submission are firstly that the applicant was unable to fetch the relevant information in time and secondly applicant has faced some personal problem, due to which the applicant could not send the property statement well in time.
