Subject : Regarding submission of statements of Movable and Immovable Property by the Judicial Officers.

Respected Sir,

I wish to submit with reference to Hon'ble High Court's letter no. 14325/IV-h-16/Admin A-IV/dated 03.12.2021: Allahabad directing to submit statement of movable and immovable property, specifying the reasons of delay, if any. In compliance to the directions of the Hon'ble Court, I am furnishing the details of movable and immovable property on prescribed performa for the Financial Year – 2015-16, 2016-17, 2017-18, 2018-19, 2019-20 and 2020-21 with this letter.

Sir, I have to most humbly submit that I could not furnish the above mentioned statements at the due time as I was transferred from Lucknow to Kaushambi in February, 2016 and from Kaushambi to New Delhi (on deputation) in February, 2018 and then again from New Delhi to Lucknow in July, 2020. During this period, I had to go on Haj Pilgrimage and also fallen ill in New Delhi and then the severe Covid-19 Pandemic lead to a long lockdown making it difficult to work in usual manner. Moreover, my mother suffered Heart Attack and got admitted to hospital for surgery and later on my entire family got infected with Covid-19 Virus. After the pandemic, continuous training programmes have been going on in the academy as the entire training schedule got delayed due to Covid-19 Pandemic. Owing to the medical condition of my mother and consequent treatment as well as my own medical condition and official commitment, the statement could not be submitted by me for which I tender an unconditional apology.

It is most humbly requested that whatsoever delay is there, it is due to the inevitable circumstances for which I seek apology from the Hon'ble Court and assure the Hon'ble Court that all necessary care and caution shall be taken by me so that no such delay occurs in future.




I, therefore, most humbly request that this statement may kindly be placed before the Hon'ble Court, with request to condone the delay and kind consideration of the matter.

I am directed to invite your good self's kind attention to the Hon'ble Court Circular Letter No. 63/IV-h-16/Admin (A-4) dated 10.12.1998 and Circular Letter No. 16/IV-h-16/Admin. (A-4) dated 13.05.2004, regarding submission of statements of Movable and Immovable Property by the Judicial Officers.

In this regard, Hon'ble Court has been pleased to direct as under-

All Judicial Officers be strictly directed to submit their statements of movable and immovable property at the time of entering the Judicial Service and thereafter regularly at the interval of two Financial Years i.e. in every third Financial Year, specifying the reasons of delay, if any. Statements of movable and immovable property, if due, be strictly submitted within a week, failing which taking of strict action may be considered by the Hon'ble Court.
