I entered in U.P. Judiciary in 9 January, 2004. I was posted at Bareilly in Junior Division at Bareilly from 9 January to June, 2007 & in June, 2007 I was transferred from Bareilly to Aligarh. I was posted in Aligarh up to June 2010 & in June 2010 I was transferred to Azamgarh. My salary account which opened in January 2004 in Bareilly was terminated by me in Bareilly & a new salary account was opened in Aligarh Jun 2007 & this account was also terminated by me in June 2010 at Aligarh. Further a new salary account was started in Azamgarh in S.B.I. & This S.B.I. account of my salary is going on yet now. I had no any knowledge about transfer of bank account to another district. At this time I have no any knowledge that in Bareilly my salary account was in which Bank And my both account was terminated in Bareilly & Azamgarh. Bank account in Azamgarh had been opened by me with 500 rupees. I have no any account except this S.B.I. account. I have no any statement of my bank account upto Bareilly. All the salary of my bank account upto Aligarh had been expended on my family, But some policies had been purchased by me upto Aligarh. Last premium of my policies was being given in 2013 and more than 7 years I have not given any premium and all the policies are suspended from 7-8 years.

I have only one son aged about 14 years, which is taking education in 10th class in Kasganj. I have only one immovable property in Bareilly. In the name of my wife & my son no any immovable property.

Treatment of Gynaecology problem of my wife was running **from 2008**. This treatment was going on up to **December 2018**. In **June 2018 the uterus & both ovary** was **ejected** from my wife's abdomen by **medical operation**. My son had a **knee problem**. The knees of both legs was so near to each other. The knees of both legs used to **bump in to each other**. In **April 2019 & December 2020 & August 2021 Three** medical operation had been done on my son knees.
