Subject: Regarding submission of statement about immovable & movable properties of Smt. Anukriti Sant the then Addl. Civil Judge (J.D.), Agra presently posted as Civil Judge (S.D./ F.T.C.), Jalaun at Orai As stated in Letter No. 3463/IV-4587/Admin (A-4)/ Dated: Allahabad March 16, 2024.

Respected Sir,

With utmost regards, it is most humbly submitted before your goodself that please refer to your letter No. 3463/IV-4587/Admin (A-4)/ Dated: Allahabad March 16, 2024 of which a copy has been endorsed to me also, wherein I am required to inform about the source of money of purchasing/acquiring the wagon-R car, gold 850 grams, silver-2 Kg, 2 diamond set, 3 Ring, Bracelet 1, Platinum set-2, rings-2, bracelet-1, also I have been directed to resubmit my first property statement with required information/explanation through e services portal.

On the above subject I am very humbly to submit that the property mentioned by me in my property statement submitted to the Hon'ble Court vide my letter dated 11-03-2019 was all inherited by me from my parents and somewhat from my in-laws. The details of which were narrated to me by my mother while she was almost on death bed. Unfortunately my mother suddenly fell ill in January -2018 and fourth stage of pancreatic cancer was detected to her. Doctors told her that she has only about 6 or 7 months life left with her due to this fatal & life taking disease.

It is under this horrible circumstances my mother told me about these ornaments etc. here as under stating that " **Anukriti I do not have much time of life with me, therefore its my moral responsibility to tell you as your mother that-**

- 1) Your Grandmother handed over to me about 300 grams of gold ornaments of her wishing them to be given to you in your wedding.
- 2) Your maternal grandmother handed over to me about 250 grams of ornaments (Gold) wishing them to be given to you in your wedding.
- 3) About 300 grams gold ornaments, three diamond rings, two diamond set, 1 bracelet of diamond and about 2 kg silver of mine to you.

These approximately 850 grams gold ornaments I inherited from my grandmother, maternal grandmother and from my own mother and unfortunately none of them is present in this world.

Wagon-R car was purchased by my father in my name in the year 2013 to facilitate me to attend my college of LLB in RMLNLU, Lucknow which happen to be about 20kms away from our residence in Gomti Nagar Lucknow.

Sir, Keeping in view the dangerous disease of fourth stage of pancreatic cancer of my mother, as per very natural wishes of my esteemed mother filling up of my 'Godh Bharai Ceremony' was done before her in the month of June - 2018 wherein my in-laws gifted to me two rings, one bracelet, and 2 platinum set. Thus these are all the sources of all above property as told by my late mother.

Sir incidentally I may mention that my grandfather was an IAS officer who was living with us jointly. My father was Chief General Manager in Samaj Kalyan Nigam of U.P. and my maternal grandfather was a senior engineer in P.W.D of U.P. I am the only daughter of my father and grand parents was living with us jointly. Thus all the immovable & movable property disclosed by me in my property statement submitted by me to the Hon'ble court is inherited by me from my parents who were by the grace of god in a good financial position.

It is also pertinent to mention here that by mistake and due to non-availability of my PPF pass book at the place of my posting I wrongly mentioned about the PPF account No 38149325882 in the property statement submitted by me vide my letter dated 11-03-2019. My PPF account came into existence on 28-12-2018 (copy of PPF passbook attached) which means I had no PPF account at the time of my joining that's why I have rectified the same in this revised property statement submitted.

Sir, regarding the late submission of property statement caused on account of my ignorance of rules being new entrant in the service for which I tender my unconditional apology to Hon'ble Court with a submission that it will not be repeated in future. In the above circumstances I pray from the Hon'ble court to please condone the delay.

Hope this will be enough to pacify your queries and it is most humbly requested before your goodself that kindly place my letter before the Hon'ble Court for its kind & generous consideration.
