In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19), 2019-21 (2019-20 & 2020-21) and 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:


1. In the financial years 2017-19 (2017-18 & 2018-19), his gross income from salary is Rs.25,12,429/- and total deductions/Savings/investments NPS, GIS, Income Tax, Insurances, Sukanya Samriddhi Yojna, FD and RD are Rs.7,97,126/-. The balance of Rs.48,888/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.17,64,191/- (Rs.17,15,303/- from salary and Rs.48,888/- from saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2017-19 (2017-18 & 2018-19).

It is pertinent to mention here that the officer's wife (Excise and Taxation officer, Government of Haryana) had an annual income of Rs.7,96,379/- for the financial year 2017-18 and Rs.9,28,106/- for the financial year 2018-19.

2. In the financial years 2019-21 (2019-20 & 2020-21). Total gross income is Rs.47,81,929/- (Income from salary is Rs.46,46,230/- and income from maturity amount of RD is Rs.1,35,699/-) total deductions/Savings/investments NPS, GIS, Income Tax, Insurances, Sukanya Samriddhi Yojna, FD and Repayment of home loan are Rs.25,73,227/-. The balance of Rs.97,346/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.22,08,702/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2019-21 (2019-20 & 2020-21).

It is pertinent to mention here that the officer's wife (Excise and Taxation officer, Government of Haryana) had an annual income of Rs.9,42,835/- for the financial year 2019-20 and Rs.9,74,208/- for the financial year 2020-21.

3. In the financial years 2021-23 (2021-22 & 2022-23), his gross income from salary is Rs.51,96,485/- total deductions/Savings/investments NPS, GIS, Income Tax, Insurances, PPF, Sukanya Samriddhi Yojna and Repayment of home loan are Rs.31,18,683/-. The balance of Rs.17,030/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.20,94,832/- (Rs.20,77,802/- from salary and Rs.17,030/- from saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2021-23 (2021-22 & 2022-23).





It is pertinent to mention here that the officer's wife (Excise and Taxation officer, Government of Haryana) had an annual income of Rs.12,91,352/- for the financial year 2021-22 and Rs.13,50,140/- for the financial year 2022-23.



In this regard, officer verbatim: "With due respect it is most humbly submitted that due to the bonafide mistake I miscalculated the policy block of financial year 2017-18 and 2018-19 as 2018-19 and 2019-2020 and under this wrong impression earlier I filed my property statement for financial year 2018-19 and 2019-20. It is also humbly submitted that during 28-02-2020 to 02-03-2021 I remained on deputation in Central Administrative Tribunal. And also due to Covid-19 situations I could not filed my property statement within the expected time for that I am tendering my unconditional apology and also undertake that in future I will file my property statement on time. For this time kindly condone my mistake."

The movable and immovable property statement for the financial years 2019-21 (2019-20 & 2020-21) was submitted by the officer online dated 10.10.2022 at Flag 'E-2', which were due to be submitted up to the end of the F.Y. 2021-22 i.e. 31.03.2022. As such there is delay in submitting the same. In this regard, officer verbatim: "With due respect it is most humbly submitted that due to the bonafide mistake I miscalculated the policy block of financial year 2019-20 and 2020-21 as 2020-21 and 2021-2022 and under this wrong impression earlier I filed my property statement for financial year 2020-21 and 2021-22. It is also humbly submitted that during 28-02-2020 to 02-03-2021 I remained on deputation in Central Administrative Tribunal. And also due to Covid-19 situations I could not filed my property statement within the expected time for that I am tendering my unconditional apology and also undertake that in future I will file my property statement on time. For this time kindly condone my mistake."

The movable and immovable property statement for the financial years 2021-23 (2021-22 & 2022-23) was submitted by the officer online dated 05.08.2023, which were due to be submitted up to the end of the F.Y. 2023-24 i.e. 31.03.2024 at Flag 'E-3'. As such there is no delay in submitting the same.

In this connection it is submitted that Sri Surender Kumar had already submitted his property statement held at the time of Joining in to U.P. Higher Judicial Service, which had been already seen by Hon'ble Mr. Justice Anil Kumar, the then Administrative Judge, Mathura Judgeship at Flag-'Z', and the said statement is at Flag-'M'.

It is pertinent to mention here that as per resolution dated 12.07.2013 at 'Flag R' of Hon'ble the Administrative Committee, the matter is to be submitted before Hon'ble The Chief Justice, as the officer is presently posted at Hon'ble High Court, Allahabad.
