May kindly see the property statement online received at Flag 'X-1' & 'X-2' from Sri Avanish Kumar Pandey, Registrar (J)(Nazarat), High Court, Lucknow Bench, Lucknow regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 and 2020-21) & 2021-23 (2021-22 and 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 and 2020-21) & 2021-23 (2021-22 and 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

1. In the financial years 2019-21 (2019-20 and 2020-21), his gross income from salary is Rs.39,39,594/- and total deductions/Savings/investments CPF, GIS, Income Tax, PPF, Repayment of loan and FD are Rs.16,05,599/-. The balance of Rs.1,16,364/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.24,50,359/- (Rs.23,33,995/- from salary and Rs.1,16,364/- from saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting three members in the financial years 2019-21 (2019-20 and 2020-21).

2. In the financial years 2021-23 (2021-22 and 2022-23) his gross income from salary is Rs.45,57,560/- and total deductions/Savings/investments CPF, GIS, Income Tax, Repayment of loan and Insurances are Rs.20,22,033/-. The balance of Rs.2,15,388/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.25,35,527/- was therefore available with him to meet out the household expenditure of his family consisting three members in the financial years 2021-23 (2021-22 and 2022-23).

In this connection, it is submitted that the Officer has already submitted his property statement up to the financial years 2017-19 offline, which had already been seen by Hon'ble Mr. Justice Abhinava Upadhyaya, the then Administrative Judge, Varanasi Judgeship in the Misc. file of the officer at flag 'Z'.

The movable and immovable property-statement for the financial years 2019-21 (2019-20 and 2020-21) had been submitted by the Officer online (e-Services portal) dated 21.12.2021 at Flag 'A-1'. Which were due to be submitted up to the end of the financial years 2021-22 i.e 31.03.2022. As such, there is no delay in submitting the same.

The movable and immovable property-statement for the financial years 2021-23 (2021-22 and 2022-23) had been submitted by the Officer online (e-Services portal) dated 02.04.2024 at Flag 'A-2'. Which were due to be submitted up to the end of the financial years 2023-24 i.e 31.03.2024. As such, there is only two days delay in submitting the same.
