May kindly see the property statement received online from Sri Prabha Nath Tripathi, Special Judge, (Pre. Cor. Act), Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income from salary and arrear is Rs.42,02,093/- and total deductions/savings/investment against GIS, GPF, PPF, Insurance, Mutual Fund and Income Tax are Rs.16,13,157/- and the balance of his savings bank account(s) is also increased by Rs.6,68,917/- in this financial year from previous year's balance, total of which is Rs.22,82,074/-. Thus, a sum of Rs.19,20,019/-was therefore available with him to meet out the household expenditure of his family consisting two members of the financial year 2020-2022 (2020-21 & 2021-22).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id: P00004252021 (Old Case Id: 2455) and the same has been seen by Hon'ble Mr. Justice Mahesh Chandra Tripathi, the then Administrative Judge, Lucknow Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 25.02.2024. As such, there is delay in submitting the same from the part of the officer for which he has stated that "the Property Statement for the Financial Year-2020-21 & 2021-22 were supposed to be sent in the next Financial Year 2022-23. However, I was transferred from District Basti to District Lucknow in the middle of the term and took Charge on 05-12-2022 in Lucknow Judgeship. Subsequently due to the demise of my father On- 23-01-2023. I had to take Earned Leave. After assuming office, I was busy with the Judicial Work, which led to the delay in sending the Property Statement, for which I apologize. I kindly request your forgiveness for the delay caused. In the future I will ensure the timely submission of Property Statements", in the remark column.

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Sri Prabha Nath Tripathi, Special Judge, (Pre. Cor. Act), Lucknow, be laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
