May kindly see the property statement received online from Sushri Richa Kesarwani, Civil Judge (Junior Div.), Lucknow regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2019-2021 (13.12.2019-31.03.2020 & 2020-21), the Gross income from salary is Rs.13,50,542/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF, NSC and Insurances are Rs.4,72,762/- and the balance of her savings bank account is also increased by Rs.4,34,477/- in this financial year from previous year's balance, total of which is Rs.9,07,239/-. Thus, a sum of Rs.4,43,303/- was therefore available with herself to meet out the household expenditure in the financial year 2019-2021 (2019-20 & 2020-21).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements held at the time of joining into U.P. Judicial Service online against Case Id: P00050332021 (Old Case Id: 7201) and the same has been seen by Hon'ble Mr. Justice Sameer Jain, the then Administrative Judge, Bhadohi Judgeship with remark "The officer must be more cautious in future in submitting the property statement in time."

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has firstly submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 26.02.2024. As such, there is delay in submitting the same from the part of the officer for which she has stated in the remark column of the movable proforma, that "I apologise for delay in filing Property Statement."

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Sushri Richa Kesarwani, Civil Judge (Junior Div.), Lucknow, be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
