May kindly see the property statement online received from Sri Ashish Kumar Chaurasia, Additional District & Sessions Judge, Lucknow regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2020-22 (2020-21 & 2021-22), his gross income from salary is Rs.41,33,360/- and total deductions/Savings/investments against, Deposits in Saving Bank Account, NPS, GIS, Income Tax, PPF, Repayment of Personal Loan and Insurances are Rs.16,12,092/-. The balance of Rs.43,935/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.25,21,268/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2020-22 (2020-21 & 2021-22).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2018-20 (2018-19 & 2019-20) online against case id- P00052292022 and same has been processed before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 25.02.2024. As such, there is day delay in submitting the same. In this regard officer verbatim: " the property statement for the Financial Year 2020-21 and FY 2021-22 was to be filed in appropriate time after ending financial year 2021-22, but at the time of preparing details regarding property statement, father of applicant was beset with arthritis in right leg and for the treatment, my father was diagnosed in the month of August, 2022 and doctor suggested operation. In view of this suggestion, after few month my father was operated and his knee was transplanted. Few month later, my father was ill and then diagnosed hernia. The applicant's father was admitted and operated. The applicant's mother was already died on June, 14th, 2021. Being the only son in the family, all the responsibilities was with the applicant, as applicant was in depression and could not fill the property statement in given time. Therefore, keeping the above facts in view, please forgive the delay in filling the property details. With due respect, applicant assures Hon'ble Lordship, the delay with respect to filling property statement will not occur in near future again."

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Ashish Kumar Chaurasia, Additional District & Sessions Judge, Lucknow be laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship Judgeship for His Lordship's kind perusal and orders?
