May kindly see the property statement received online from Dr. Laxmi Kant Rathaur, Addl. District & Sessions Judge, Prayagraj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2021-2023 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2021-2023 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2021-2023 (2021-22 & 2022-23), the Gross income is Rs.82,08,015/- (Rs.57,98,015/- from salary, Rs.70,000/- from Agriculture, Rs.3,00,000/- from Leave Encashment, Rs.4,00,000/- from Maturity of his father's NSC, Rs.5,40,000/- from self and his wife's PPF A/c, Rs.2,00,000/- from House rent and savings & Rs.9,00,000/-from his wife's MIS of GPO) and total deductions/savings/investment against NPS, GIS, PPF, Sukanya Samridhhi Account, House loan repayments including Lump Sum amount paid other than EMI, SIPs, Mutual Funds and Income Tax is Rs.72,65,677/- and the balance of his savings bank account(s) is also decreased by Rs.5,47,188/- in this financial year from previous year's balance. Thus, a sum of Rs.14,89,526/- (Rs.9,42,338/- from salary and Rs.5,47,188/- from SB accounts) was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2021-2023 (2021-22 & 2022-23).

It is pertinent to mention here that his wife have income of Rs.3,15,983/- & Rs.2,10,195/- from Tution and Interest in the financial year 2021-22 & 2022-23 respectively (as mentioned by the officer).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2019-2021 (2019-20 & 2020-21) online against Case Id : P00029492021 (Old Case Id : 5091) and the same has been seen by Hon'ble Mr. Justice Suneet Kumar, the then Administraive Judge, Agra Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2021-2023 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial year 2021-2023 (2021-22 & 2022-23) vide online dated 01.03.2024. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2021-2023 (2021-22 & 2022-23) of Dr. Laxmi Kant Rathaur, Addl. District & Sessions Judge, Prayagraj, be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Prayagraj Judgeship for His Lordship's kind perusal and orders?
