May kindly see the online property statements received from Smt. Tanu Bhatnagar, Additional District & Sessions Judge, Lucknow regarding submission of complete statement of movable & immovable properties acquired/held by her or any member of her family of the financial years 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

1. In the financial years 2021-23 (2021-22 & 2022-23), Total Gross salary and arrears are Rs.41,93,507/and total deductions/savings/ investment against GIS, Income Tax, NPS, Mutual Fund, PPF a/c, FDR, Car loan, Home loan and the balance of his savings bank account(s) is also enhanced for Rs.8,86,430/in this financial year from previous year's balance, total of which is Rs.47,09,378/- i.e., more than her income.

It is pertinent to mention here that her Husband is Judicial Officer having annual income of Rs.21,88,720/- and Rs.22,57,312/- in the financial years 2021-22 and 2022-23 respectively. After calculating the deductions, expenses, savings etc. of officer's husband Sri Rohit Singh, Special Judge (Ayurved Scam Matter), Lucknow for the financial years 2021-23, Rs.19,44,577/- was available with him to meet out the household expenditure of his family consisting of three members in both of the financial years and the balance of his savings bank account(s) is also reduced for Rs.2,60,798/- in the aforesaid financial years. So, it appears that she has to meet out the household expenses of her family consisting of three members in this financial year by the income of her husband.

Property statement of the financial year 2021-23 of officer's husband Sri Rohit Singh, Special Judge (Ayurved Scam Matter), Lucknow has already been laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow for His Lordship's kind perusal and orders on eService ID P00000652024.

In this connection, it is submitted that the officer has already submitted her property statement of the financial year 2019-21 online, which has already been seen online by Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow on eService ID P00037312021.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March,2024. She has submitted movable and immovable property statements of the financial year 2021-23 (2021-22 & 2022-23) vide online dated 01.03.2024. As such, there is no delay in submitting the same.
