May kindly see the property statement received online from Sri Lokesh Varun, Addl. District & Sessions Judge, Kannauj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2006-2008 (2006-07 & 2007-08) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2006-2008 (2006-07 & 2007-08) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial year 2006-2008 (2006-07 & 2007-08)**, the Gross income from salary is Rs.3,91,465/- and total deductions/savings/investment against GIS, Insurances, Loan repayments including down payment and Income Tax is Rs.1,45,129/-, and the balance of his savings bank account is Rs.20,190/- in this financial year, total of which is Rs.1,65,319/-. Thus, a sum of Rs.2,26,146/- was therefore available with him to meet out the household expenditure of his family consisting two members of the financial year 2006-2008 (2006-07 & 2007-08).

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of joining into U.P. Judicial service online against Case Id: P00061522022 and the same has been processed before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Kannauj Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2006-2008 (2006-07 & 2007-08) in its next financial year i.e., 2008-09 upto March 2009. In this regard, it is submitted that earlier, the officer had submitted his property statements at the time of joining Judicial Service and for calander year 2006-07, 2007-08, 2008-09 & 2009-10 in offline mode vide Endorsement no. 2297/2010 admin. Moradabad dated. 14.09.2010. As such, there is delay in submitting aforesaid property statements from the part of the officer for which, he has stated that *"I am new in service due to which is failed to submit the statements within time. Therefore I humbly request you to please accept my property statement. I shall be highly obliged. In future, I will be very much regular in sending statements to Hon'ble Court."*The said property statements want some more requirements of details etc. and accordingly a query was sent for the same at that time. However, now the officer has submitted the said statements in online mode as fresh, which is likely to be placed before Hon'ble the Administrative Judge, Kannauj now.

May, therefore, if approved, property statements for the financial year 2006-2008 (2006-07 & 2007-08) of Sri Lokesh Varun, Addl. District & Sessions Judge, Kannauj, be laid before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Kannauj Judgeship for His Lordship's kind perusal and orders?
