May kindly see the property statement received online from Sri Ravi Kant-III, Addl. District & Sessions Judge, Agra regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income is Rs.55,09,737/- (Rs.44,57,465/- from Salary, Rs.17,800/- from SB account interest, Rs.2,04,000/- from Rent, Rs.1,00,000/- from LIC money back and Rs.7,30,472/- from Maturity of FDRs) and total deductions/savings/investment against GIS, GPF, PPF, Insurance, various SIPs & Mutual Funds, Sukanya Samridhhi Account, Loan repayment and Income Tax are Rs.40,74,477/-. Thus, a sum of Rs.14,35,260/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2020-2022 (2020-21 & 2021-22) and the balance of his savings bank account(s) is also decreased by Rs.6,32,424/- in this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id : P00007072021 (Old Case Id : 2770) and the same has been processed before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 29.02.2024. As such, there is delay in submitting the same from the part of the officer for which he has stated in his letter as attachment dated. 29.02.2024, that delay caused due to his transfer, excessive work and lack of time, for which he apologizes and assures that he does not repeat such mistake and will sent property statements on time in future.

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Sri Ravi Kant-III, Addl. District & Sessions Judge, Agra, be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders?
