May kindly see the property statement received online from Sri Lokesh Varun, Addl. District & Sessions Judge, Kannauj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2008-2010 (2008-09 & 2009-10) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2008-2010 (2008-09 & 2009-10) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2008-2010 (2008-09 & 2009-10), the Gross income from salary is Rs.6,02,374/- and total deductions/savings/investment against GIS, CPF, NSC, Insurances, Loan repayments, PM relief fund and Income Tax is Rs.3,14,158/- and the balance of his savings bank account(s) is also increased by Rs.69,859/- in this financial year from previous year's balance, total of which is Rs.3,84,017/-. Thus, a sum of Rs.2,18,357/- was therefore available with him to meet out the household expenditure of his family consisting of three members of the financial year 2008-2010 (2008-09 & 2009-10).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2006-2008 (2006-07 & 2007-08) online against Case Id: P00001812024 and the same has been processed before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Kannauj Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2008-2010 (2008-09 & 2009-10) in its next financial year i.e., 2010-11 upto March 2011. In this regard, it is submitted that earlier, the officer had submitted his property statements at the time of joining Judicial Service and for calendar years 2006-07, 2007-08, 2008-09 & 2009-10 in offline mode vide Endorsement no. 2297/2010 admin. Moradabad dated. 14.09.2010. As such, there is no delay in submitting the same taking into consideration of his first submission earlier. The said property statements want some more requirements of details etc. and accordingly a query was sent for the same at that time. However, now the officer has submitted the said statements in online mode as fresh, which is likely to be placed before Hon'ble the Administrative Judge, Kannauj now.

May, therefore, if approved, property statements for the financial year 2008-2010 (2008-09 & 2009-10) of Sri Lokesh Varun, Addl. District & Sessions Judge, Kannauj, be laid before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Kannauj Judgeship for His Lordship's kind perusal and orders?
