May kindly see the property statement received online from Sri Lokesh Varun, Addl. District & Sessions Judge, Kannauj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income is Rs.48,96,229/- (Rs.46,04,484/- from salary including arrears, Rs.7,582/- from NSC encashed, Rs.2,42,638/- from RD and Rs.41,525/- from Interest of SB account) and total deductions/savings/investment against GIS, CPF, PPF, RD, NSC, Sukanya Samriddhi Yojna, Insurances, Loan repayments and Income Tax is Rs.31,23,083/- and the balance of his savings bank account(s) is also increased by Rs.8,54,053/- in this financial year from previous year's balance, total of which is Rs.39,77,136/-. Thus, a sum of Rs.9,19,093/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2020-2022 (2020-21 & 2021-22).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id : P00061542022 and the same has been processed before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Kannauj Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has firstly submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 06.03.2024. As such, there is delay in submitting the same from the part of officer, for which he stated that *"It is with my sincere regrets that because of prevailing pandemic due to which I could not collect the requisite bank documents and also my parent long illness who were with me and after demise of my father, I could not submit my property statements. I therefore with profound regards and deepest respect, humbly request your goodself to condone the delay in submission, kindly accept my property statement for which I shall be highly obliged."*, in the remark column of the property statement for the financial year 2020-2022 (Case Id : P00002012024).

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Sri Lokesh Varun, Addl. District & Sessions Judge, Kannauj, be laid before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Kannauj Judgeship for His Lordship's kind perusal and orders?
