May kindly see the online property statements received from Sri Gyanender Singh Yadav, Additional District & Sessions Judge, Moradabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2020-21 & 2021-22 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-21 & 2021-22, Total Gross income is Rs.42,28,203/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, Home loan, PPF a/c, Insurance policy and the balance of his savings bank account(s) is enhanced for Rs.4,96,294/- this financial year from previous year's balance are Rs.28,03,437/-. Thus, a sum of Rs.14,24,766/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years..

It is pertinent to mention here that his wife's annual income is Rs.2,00,000/- to Rs.2,50,000/- per annum from Agricultural Income from land obtained her parental side and she is an income tax payee.

In this connection, it is submitted that the officer has also submitted his property statement upto the financial year 2017-18, which has already been seen online by Hon'ble Mr. Justice Vivek Agarwal, the then Administrative Judge, Moradabad on eService ID P00001992019. And for the property statements of the financial years 2018-20, a detailed office note has been laid before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Moradabad for His Lordship's kind perusal & order on eService ID P00052682022.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements for the financial years 2020-21 & 2021-22 firstly vide online dated 07.03.2024. As such, there is delay in submitting the same from the part of the officer for which he has stated that "*he failed to submit his property statement within time due to his personal family problem, like illness of his wife for long period. His apologies for this inordinate delay in submission of his property statement before Hon'ble Court. He shall be more careful in future. It is his kind request to put his explanation before Hon'ble Court for kind consideration*", mentioned in his attachment dated 07.03.2024.

May, therefore, if approved, property statements for the financial year 2020-21 & 2021-22 of Sri Gyanender Singh Yadav, Additional District & Sessions Judge, Moradabad be laid before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Moradabad Judgship for His Lordship's kind perusal and orders?
