In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2021-23 (2021-22 & 2022-23), his gross income from salary is Rs.32,95,634/and total deductions/Savings/investments against, Deposits in Saving Bank Account, NPS, GIS, Income Tax and PPF are Rs.21,37,476/-. The balance of Rs.9,38,420/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.11,58,158/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2021-23 (2021-22 & 2022-23).

It is to pertinent mention here that officer's wife (Judicial officer in Uttar Pradesh) having annual income Rs.7,35,615/- for the financial years 2021-22 & 2022-23 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2019-21 (2019-20 & 2020-21) online against case id- P00011362021 (old case id-3233) and same has been processed before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Moradabad Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements for the financial years 2021-23 (2021-22 & 2022-23) vide online dated 20.03.2024. As such, there is no day delay in submitting the same.
