

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Sri Prashant Mishra-II, Addl. Civil Judge (Sr.Div.)/ACJM., Amroha regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial year 2020-2022 (2020-21 & 2021-22)**, the Gross income from salary is Rs.30,34,333/- and total deductions/savings/investment against GIS, NPS, PPF, Insurances, Loan repayments and Income Tax is Rs.15,05,964/- and the balance of his savings bank account(s) is also increased by Rs.44,375/- in this financial year from previous year's balance, total of which is Rs.15,50,339/-. Thus, a sum of Rs.14,83,994/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2020-2022 (2020-21 & 2021-22).

It is pertinent to mention here that his wife have annual income of Rs. 3 lakhs Approx. from Business.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id : P00008752020 (Old Case Id : 1742) and the same has been processed before Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Amroha Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has firstly submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 18.03.2024. As such, there is delay in submitting the same from the part of officer, for which he stated in the remark column, that:

*"I am writing this to express my sincere apologies for the delay in filing my property statement. The last two years have presented unprecedented challenges due to the ongoing COVID-19 pandemic. Like many others, I have had to navigate through various personal and Family disruptions caused by the pandemic and Lockdown. Additionally, during this time, I was also undergoing a period of promotion and two sudden transfers from one court to another court, which further added to the demands on my time and attention.*

*Despite my best efforts to manage these transitions effectively, I acknowledge that I fell short in meeting the deadline for filing the property statement. It is humbly submitted that this delay was not intentional.*

*Once again, I tender my unconditional apologize for delay and missing the deadlines. I assure your goodself that in future I will adhere all the deadlines."*

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Sri Prashant Mishra-II, Addl. Civil Judge (Sr.Div.)/ACJM., Amroha, be laid before Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Amroha Judgeship for His Lordship's kind perusal and orders?
