May kindly see the property statement received online from Sri Manoj Kumar Bhaskar, Nyayadhikari, Gram Nyayalaya, Handia-Prayagraj, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial year 2019-2021 (2019-20 & 2020-21)**, the Gross income is Rs.24,56,038/- (Rs.12,69,420/- from salary, Rs.6,50,000/- from FD maturity, Rs.2,30,420/- from SBI Life maturity, Rs.43,130/- from Interest from SB and FD and Rs.2,63,068/- from Bonus, CEA, CGGIS, TA Bill & Gratuity from previous Post Office Job) and total deductions/savings/investment against NPS, GIS, PPF, Loan repayments, Insurances and Income Tax is Rs.5,60,080/- and the balance of his savings bank account(s) is also increased by Rs.8,53,769/- in this financial year from previous year's balance, total of which is Rs.14,13,849/-. Thus, a sum of Rs.10,42,189/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2019-2021 (2019-20 & 2020-21).

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of joining online against Case Id : P00003272020 (Old Case Id : 983) and the same has been seen by Hon'ble Mr. Justice Narendra Kumar Johari, Administrative Judge, Fatehpur Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 19.03.2024. As such, there is delay in submitting the same from the part of the officer for which officer has stated that *"the delay in submitting property statement due to Covid-19 is deeply regretted and sincerely apologized to the Hon'ble. With regards"*, in the remark column of movable proforma.

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Sri Manoj Kumar Bhaskar, Nyayadhikari, Gram Nyayalaya, Handia-Prayagraj, be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Allahabad (Prayagraj) Judgeship for Her Lordship's kind perusal and orders?
