Thus a sum of Rs.25,22,690/- (Rs.23,13,725/- from salary and 2,08,965/- from saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2021-23 (2021-22 & 2022-23).

it is pertinent to mention here that officer's wife is a Govt. Teacher having annual income of Rs. 7,00,000/- for both the financial year.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2019-21 (2019-20 & 2020-21) online against case id-P00043862021 (old case id-6542), which had already been seen by Hon'ble Mr. Justice Suneet Kumar, the then Administrative Judge, Agra Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements for the financial years 2021-23 (2021-22 & 2022-23) vide online dated 19.03.2024. As such, there is no day delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 & 2022-23) of Sri Pradeep Kumar Singh-I, Additional District & Sessions Judge, Agra be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders?
