In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2021-23 (2021-22 & 2022-23), his gross income from salary and other sources are Rs.43,28,134/- and total deductions/Savings/investments against, Deposits in Saving Bank Account, NPS, GIS, Income Tax, SIP, Sukanya Samriddhi Yojna and PPF are Rs.28,15,048/-. The balance of Rs.2,29,205/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.15,13,086/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2021-23 (2021-22 & 2022-23).

It is to pertinent mention here that officer's wife (Assistant Professor) having annual income was Rs.4,80,000/- for the financial years 2021-22 & 2022-23 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2019-21 (2019-20 & 2020-21) offline, which had already been seen by Hon'ble The Chief Justice in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements for the financial years 2021-23 (2021-22 & 2022-23) vide online dated 30.03.2024. As such, there is no day delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 & 2022-23) of Sri Ran Vijay Pratap Singh, A.D.J. (FTC), Gautambuddha Nagar be laid before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Gautambuddha Nagar Judgeship for His Lordship's kind perusal and orders?
