May kindly see the property statement online received from Sri Ran Vijay Pratap Singh, A.D.J. (FTC), Gautambuddha Nagar regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2021-23 (2021-22 & 2022-23), his gross income from salary and other sources are Rs.43,28,134/- and total deductions/Savings/investments against, Deposits in Saving Bank Account, NPS, GIS, Income Tax, SIP, Sukanya Samridhhi Yojna and PPF are Rs.28,15,048/-. The balance of Rs.2,29,205/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.15,13,086/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2021-23 (2021-22 & 2022-23).

It is to pertinent mention here that officer's wife (Assistant Professor) having annual income was Rs.4,80,000/- for the financial years 2021-22 & 2022-23 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2019-21 (2019-20 & 2020-21) offline, which had already been seen by Hon'ble The Chief Justice in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements for the financial years 2021-23 (2021-22 & 2022-23) vide online dated 30.03.2024. As such, there is no day delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 & 2022-23) of Sri Ran Vijay Pratap Singh, A.D.J. (FTC), Gautambuddha Nagar be laid before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Gautambuddha Nagar Judgeship for His Lordship's kind perusal and orders?
