In the financial years 2020-22 (2020-21 & 2021-22), total Gross salary (including alltype of arrears) is Rs.38,24,298/- and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, Home Loan EMI, Car Loan EMI, LIC Policies and Personal loan are Rs.18,58,540/-. Thus, a sum of Rs.19,65,758/- was available with her to meet out the household expenditure of her family consisting of four members in both of the financial years. And balance of her SB accounts has also been reduced for Rs.9,36,513/- this financial year from the balance of previous year.

It is pertinent to mention here that her husband is posted as Director (IT)/Scientist in Ministry of I.T. Communication on CGO Complex New Delhi.

In this connection, it is submitted that the Officer has already submitted her property statements of the F.Y. 2017-18 offline and the same has been approved by the Hon'ble Mr. Justice Pankaj Naqvi, the then, Administrative Judge, Rampur Judgeship in Misc. file of the officer. And property statement of the financial years 2018-20, a detailed online note has been laid before Hon'ble Mr. Justice Manish Kumar Nigam, Administrative Judge, Auraiya for His Lordship's kind perusal and orders on eService IDP00008642021.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements of the financial years 2020-22 (2020-21 & 2021-22) vide online dated 30.03.2024. As such, there is delay in submitting the same.
