May kindly see the property statement online received from Sri Durg Narain Singh, District & Sessions Judge, Bhadohi at Gyanpur regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2022-24 (2022-23 & 2023-24) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2022-24 (2022-23 & 2023-24) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2022-24 (2022-23 & 2023-24), his gross income from salary and other sources are Rs.1,37,12,754/- (Rs.1,28,30,854/- from salary and arrears and Rs.8,81,900/- from agricultural income) and total deductions/Savings/investments against, GPF, GIS, Income Tax, PPF, FDR, Mutual Fund, Repayment of loan and Insurances are Rs.1,05,26,136/-. The balance of Rs.9,51,892/- has increased in his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.31,86,618/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2022-24 (2022-23 & 2023-24).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2020-22 (2020-21 & 2021-22) online against case id- P00062282022 ,which had already been seen by Hon'ble Mr. Justice Manish Mathur, the then Administrative Judge, Barabanki Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2022-24 (2022-23 & 2023-24) in its next financial year i.e., 2024-25 upto March 2025. He has submitted movable and immovable property statements for the financial years 2022-24 (2022-23 & 2023-24) vide online dated 26.04.2024. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2022-24 (2022-23 & 2023-24) of Sri Durg Narain Singh, District & Sessions Judge, Bhadohi at Gyanpur be laid before Hon'ble Mr. Justice Mohd. Azhar Husain Idrisi, Administrative Judge, Bhadohi at Gyanpur Judgeship for His Lordship's kind perusal and orders?
