May kindly see the online property statement received from Smt. Zeba Rauf, Additional Civil Judge (Senior Division)/ Additional Chief Judicial Magistrate, Moradabad regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2020-21 & 2021-22 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2020-21 & 2021-22, Total Gross salary is Rs.16,95,948/- and total deductions/ repayment/ savings/ investments (for both the financial years) against GIS, NPS, Income Tax, PPF, Car loan and the balance of her savings bank account(s) has been enhanced for Rs.2,31,558/- this financial year from previous year's balance, total of which is Rs.12,30,613/-. Thus, a sum of Rs.4,65,335/- was therefore available with her to meet out the household expenditure of her family consisting three members in both the financial years.

It is pertinent to mention here that her husband is also a Judicial officer and having annual income of Rs.14,33,177/-.

In this connection, it is submitted that officer has already submitted her property statements at the time of joining into Judicial Service & 2018-20 online, through which detailed notes has been submitted online before Hon'ble Mr. Justice Ajay Bhanot, Administrative Judge, Moradabad Judgeship for His Lordship's kind perusal and orders, on eService ID P00003282024 and P00057782022 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statements of the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements of the financial years 2020-21 & 2021-22 firstly vide online dated 03.04.2024. As such, there is delay in submitting the same from the part of the officer for which she has stated that "Due to heavy judicial work property statement could not filed on time. Please Forgive her", mentioned in remark column.

May, therefore, if approved, property statements of the financial years 2020-21 & 2021-22 of Smt. Zeba Rauf, Additional Civil Judge (Senior Division)/ Additional Chief Judicial Magistrate, Moradabad be laid before Hon'ble Mr. Justice Ajay Bhanot, Administrative Judge, Moradabad Judgeship for His Lordship's kind perusal and orders?
