May kindly see the property statement received online from Sri Raghubar Singh, Addl. District & Sessions Judge, Moradabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2021-2023 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2021-2023 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2021-2023 (2021-22 & 2022-23), the Gross income from salary is Rs.47,14,043/- and total deductions/savings/investment against NPS, GIS, Insurances, PPF, loans repayments including amount paid other than loan, Share, Mutual Funds and Income Tax is Rs.46,83,605/- and the balance of his savings bank account(s) is also decreased by Rs.10,24,444/- in this financial year from previous year's balance. Thus, a sum of Rs.10,54,822/- (Rs.30,378/- from salary and Rs.10,24,444/- from SB account) was therefore available with him to meet out the household expenditure of his family consisting six members of the financial year 2021-2023 (2021-22 & 2022-23).

It is pertinent to mention here that his father receives Rs.38,000/- from pension (as mentioned by the officer).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2019-2021 (2019-20 & 2020-21) online against Case Id: P00043142021 (Old Case Id: 6467) and the same has been seen by Hon'ble Mr. Justice Dinesh Kumar Singh, the then Administrative Judge, Moradabad Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2021-2023 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial year 2021-2023 (2021-22 & 2022-23) vide online dated 05.04.2024. As such, there is delay in submitting the same from the part of the officer for which he has stated in his online reply dated 08.07.2024, that due to extremely busyness in work and some family commitments, he could not submit the said property statement before the Hon'ble Court within the prescribed time period i.e. 31st March 2024 for the year 2021-23, for which he apologizes and assures that in the future, this will not be repeated and also requests to the Hon'ble Court for taking sympathetic cognizance of the above facts.

May, therefore, if approved, property statements for the financial year 2021-2023 (2021-22 & 2022-23) of Sri Raghubar Singh, Addl. District & Sessions Judge, Moradabad, be laid before Hon'ble Mr. Justice Ajay Bhanot, Administrative Judge, Moradabad Judgeship for His Lordship's kind perusal and orders?
