May kindly see the property statement received online from Sri Shiva Nand Gupta, Civil Judge (Senior Div.), Agra regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2021-23 (2021-22 & 2022-23), Gross income from salary is Rs.33,62,930/- and total deductions/savings/ investment against GIS, NPS, Income Tax, LIC, mutual fund, repayment of home loan and the balance of his savings bank account is also enhanced by Rs.97,295/- in this financial year from previous year's balance, total of which is Rs.18,48,252/-. Thus, a sum of Rs.15,14,678/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both of the financial years. It is pertinent to mention here that his wife's annual income is about Rs.3,00,000/- from business and profession, as mentioned by the officer.

In this connection, it is submitted that the Officer has submitted his property statements upto the financial years 2019-21 and the same has been processed online against Case Id : P00016492021 before Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. The officer has submitted his movable and immovable property statements for the financial years 2021-23 (2021-22 & 2022-23) vide online dated 16.04.24. As such, there is some delay in submitting the same from the part of the officer. In this regard, he has stated (in his verbatim) that "There were some medical problems as my wife was pregnant and I am blessed with a baby boy on 17.04.24. That's why It is some delay in filing current property statement. Kindly forgive me for delay and I'll make sure not to repeat it again".

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 & 2022-23) of Sri Shiva Nand Gupta, Civil Judge (Senior Div.), Agra be laid before Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders?
