May kindly see the property statement received online from Smt. Rekha Singh, Addl. Principal Judge, Family Court, Kanpur Nagar, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income is Rs.42,85,166/- (Rs.33,84,418/- from Salary, Rs.63,700/- from Agriculture, Rs.2,28,000/- from House Rent & Rs.6,09,048/- from Interest and others) and total deductions/ repayment/ savings/ investment against GIS, NPS, PPF, Insurances, loan repayments and Income Tax are Rs.14,41,944/- and the balance of her savings bank account is also increased by Rs.12,71,215/- in this financial year from previous year's balance, total of which is Rs.27,13,159/-. Thus, a sum of Rs.15,72,007/- was therefore available with her to meet out the household expenditure of her family consisting four members in the both financial year.

It is pertinent to mention here that her husband, working as Deputy Transport Commissioner, R.T.O., have annual gross income of Rs.31,24,910/- & Rs.25,53,780/- in financial year 2020-21 & 2021-22 respectively.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20), online against Case Id : P00056442022 and the same has been seen offline by Hon'ble Mr. Justice Ajit Singh, the then Administrative Judge, Maharajganj Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 15.04.2024. As such, there is delay in submitting the same from the part of the officer for which she has stated in the remark column, that "*due to critical health problem I did not submit the statement on time. Apology for the delay.*"

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Smt. Rekha Singh, Addl. Principal Judge, Family Court, Kanpur Nagar, be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders?
