May kindly see the online property statements received from Sri Amit Kumar-III, Civil Judge (Sr. Div.), Sonbhadra regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2020-21 & 2021-22 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-21 & 2021-22, total Gross income from salary & arrears (both the financial years) is Rs.28,04,340/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF, Insurance policies, Car loan, Mutual Fund and Gold bond are Rs.12,69,115/-. Thus, a sum of Rs.15,35,225/- was therefore available with him to meet out the household expenditure of himself in both the financial years. And the balance of his savings bank account(s) has also been reduced for Rs.2,65,457/- this financial year from previous year's balance.

In this connection it is submitted that the officer has already submitted his property statement for the financial years 2016-18 & 2018-20 online. A detailed online note has already been laid before Hon'ble Mr. Justice Saurabh Srivastava, Administrative Judge, Sonbhadra for His Lordship's kind perusal and orders for the financial years 2016-18 on eService ID P00002462021. Property statements of the financial years 2018-20 has already been seen online by Hon'ble Mr. Justice Rajiv Gupta, the then Administrative Judge, Saharanpur.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March,2023. He has submitted movable and immovable property statements of the financial year 2020-21 & 2021-22 vide online dated 12.04.2024. As such, there is delay in submitting the same from the part of the officer for which he has stated (in his verbatim) that *"It is humbly submitted that due to COVID-19 Pandemic, I fails to submit my property statement of term 2020-2022 on time. I feel extremely sorry for the delay caused. I will submit my property statement in future on time", mentioned in remark column of movable proforma..* 

May, therefore, if approved, property statements for the financial year 2020-21 & 2021-22 of Sri Amit Kumar-III, Civil Judge (Sr. Div.), Sonbhadra be laid before Hon'ble Mr. Justice Saurabh Srivastava, Administrative Judge, Sonbhadra for His Lordship's kind perusal and orders?
