May kindly see the online property statements received from Sri Hemant Kumar-II, Additional District & Sessions Judge, Ayodhya regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2022-23 & 2023-24 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2022-23 & 2023-24 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2022-23 & 2023-24, Total income is Rs.1,02,35,558/- [total Gross salary (including HRR & arrear) is Rs.97,85,500/-, agricultural income of Rs.3,20,000/-, encashment of Bond of Rs.60,000/- and matured amount of LIC policies of Rs.70,058/-) and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, Insurance policies, Mutual fund, PLI, Home loan and the balance of his savings bank account(s) has been enhanced for Rs.40,14,762/- this financial year from previous year's balance, total of which is Rs.89,51,961/-. Thus, a sum of Rs.12,83,597/- was therefore available with him to meet out the household expenditure of his family consisting five members for both the financial years 2022-23 & 2023-24..

It is pertinent to mention here that his mother's agricultural income of Rs.90,000/- and drawing pension of Rs.60,000/- per annum from LIC Policy as Pradhan Mantri Vaya Vandana Yojna. His wife is diploma degree holder from VLCC, derives her income approx. 2.5 lacs to 3 lacs from profession. Some of the ancestral property of the officer has been acquired by UPEIDA (A state Govt. undertaking), Copy of compensation award letter has also been attached herewith.

In this connection it is submitted that he has submitted his property statement upto the financial year 2018-20 online, which has already been seen online by Hon'ble Mr. Justice Rajesh Singh Chauhan, the then Administrative Judge, Bulandshahr. His subsequent property statements of the financial years 2020-22 has also been submitted for being placed before Hon'ble Mr. Justice Jaspreet Singh, Administrative Judge, Faizabad/Ayodhya Judgeship on separate online eService ID P00009102023.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2022-23 & 2023-24 in its next financial year i.e., 2024-25 upto March 2025. He has submitted movable and immovable property statements of the financial year 2022-23 & 2023-24 vide online dated 16.04.2024. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2022-23 & 2023-24 of Sri Hemant Kumar-II, Additional District & Sessions Judge, Ayodhya be laid before Hon'ble Mr. Justice Jaspreet Singh, Administrative Judge, Faizabad/Ayodhya Judgeship for His Lordship's kind perusal and orders?
