May kindly see the property statement submitted online dated 25.09.2019 received from Sri Rajmangal Singh Yadav, the then Chief Judicial Magistrate, Shamli at Kairana presently posted as Chief Judicial Magistrate, Firozabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2016-17, income from salary is Rs.9,20,448/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax, NPS, PPF a/cs, LIC and RD are Rs.3,61,929/-. Thus, a sum of Rs.5,58,519/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year. The balance of his savings bank account(s) is also reduced for Rs.14,356/- this financial year from previous year's balance.

In this connection it is submitted that Sri Rajmangal Singh Yadav has already submitted his property statement upto the financial year 2014-15 which had already been seen by Hon'ble Mr. Justice Rakesh Srivastava, the then Administrative Judge, Sonbhadra in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2015-16 & 2016-17 in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statement for the financial year 2016-17 vide online dated 25.09.2019. As such, there is delay in submitting the same from the part of the officer for which no explanation is submitted by him.

Hon'ble The Administrative Committee vide minutes dated 11.02.2021 has resolved that- "The property statements be submitted before The Hon'ble Administrative Judge of the district where the officer is posted".
