May kindly see the property statement received online from Sri Ghulam Mustafa, Special Judge (E. C. Act), Lakhimpur Kheri regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial year 2020-2022 (2020-21 & 2021-22)**, the Gross income from salary including arrears is Rs.41,73,657/- and total deductions/savings/investment against GIS, GPF, PM Care Fund, House loan repayments and Income Tax are Rs.22,86,671/-. Thus, a sum of Rs.18,86,986/-was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2020-2022 (2020-21 & 2021-22) and the balance of his savings bank account(s) is also decreased by Rs.3,55,547/- in this financial year from previous year's balance. It is pertinent to mention here that his wife have annual income Rs.2.90 lakh & Rs.3.00 lakh from Agriculture in the financial year 2020-21 & 2021-22 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id : P00008862021 (Old Case Id : 2964) and the same has been seen by Hon'ble Mr. Justice Rajan Roy, the then Administrative Judge, Bulandshahar Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 19.04.2024. As such, there is delay in submitting the same from the part of officer for which he has stated in the remark column, that "due to rush of work I could not submit the property statement in time for which I highly regretted for this and seek of opology."

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Sri Ghulam Mustafa, Special Judge (E. C. Act), Lakhimpur Kheri, be laid before Hon'ble Mr. Justice Pankaj Bhatia, Administrative Judge, Lakhimpur Kheri Judgeship for His Lordship's kind perusal and orders?
