May kindly see the property statement submitted online received from Sri Devendra Nath Singh, Additional Principal Judge, Family Court, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.48,52,492/- (income from salary is Rs.36,64,230/-, Agricultural income of Rs.3,58,417/-, Bank interests of Rs.35,412/-, Income Tax refund of Rs.12,580/-, Medical reimbursement of Rs.56,330/-, matured amount of NSC of Rs.84,395/-, Transfer Allowance of Rs.47,648/- and matured amount of SBI life insurance policy of Rs.5,93,480/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, Income Tax, Ioan, Insurance policies and PPF a/c are Rs.24,08,958/-. Thus, a sum of Rs.24,43,534/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice P.K.S.Baghel, the then Administrative Judge, Bulandshahr in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 23.03.2021. As such, there is no delay in submitting the same from the part of the officer.
