May kindly see the property statement received online from Sri Abhishek Kumar Pandey, Civil Judge (JD) (FTC) (14th Finance Commission), Ghaziabad, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income from salary is Rs.10,79,827/- and total deductions/savings/investment against NPS, GIS, PPF, KVP, RD, Loan repayments including amount paid other than loan and Income Tax is Rs.10,86,050/- and the balance of his savings bank account(s) is also decreased by Rs.6,84,037/- in this financial year from previous year's balance. Thus, a sum of Rs.6,77,814/- was therefore available with him to meet out the household expenditure of his family consisting five members of the financial year 2019-2021 (2019-20 & 2020-21).

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of joining online against Case Id : P00009292020 (Old Case Id : 1814) and the same has been seen by Hon'ble Mr. Justice Piyush Agrawal, the then Administrative Judge, Mau Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 01.05.2024. As such, there is delay in submitting the same from the part of the officer for which he has stated in his online reply dated 07.06.2024, that (in his verbatim) *"the first property statement was filed after joining the service which was duly approved by the Honble Court. The next return was filed under the impression that I was required to file the statement for next two financial year after filing the first return I.e. for 2020 to 2022 including the information of 2019 -20 of remaining months of November 2019 to March 2020. If any delay is caused, it is humbly requested to appolized."*

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Sri Abhishek Kumar Pandey, Civil Judge (JD) (FTC) (14th Finance Commission), Ghaziabad, be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Ghaziabad Judgeship for His Lordship's kind perusal and orders?
