May kindly see the property statement received online from Smt. Parul Kumari, Addl. Civil Judge (Junior Div.), Sonbhadra regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2021-2023 (2021-22 & 2022-23) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2021-2023 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2021-2023 (2021-22 & 2022-23), the Gross income from salary is Rs.20,53,098/- and total deductions/repayment/savings/investment against GIS, NPS, Insurances, SIP, Mutual Funds, Car Loan repayments and Income Tax are Rs.11,81,197/-. Thus, a sum of Rs.8,71,901/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2021-2023 (2021-22 & 2022-23) and the balance of her savings bank account is also decreased by Rs.1,29,913/- in this financial year from previous year's balance.

It is pertinent to mention here that her husband have annual income of Rs.5,00,000/- from Agriculture (as mentioned by the officer).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements for the financial year 2019-2021 (2019-20 & 2020-21) online against Case Id: P00004232024 and the same has been processed before Hon'ble Mr. Justice Saurabh Srivastava, Administrative Judge, Sonbhadra Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2021-2023 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. She has submitted movable and immovable property statements of the financial year 2021-2023 (2021-22 & 2022-23) vide online dated 06.05.2024. As such, there is delay in submitting the same from the part of the officer for which she has stated in her online reply dated 29.06.2024, that "With due respect I would like to inform you that the reason of the delay submission of property statement is that there was a huge crisese in my family. I have lost two of my brothers in law at early age. I was very disturbed at that time, so I was unable to submit the statement. Kindly consider my reason. I will be highly obliged to you."

May, therefore, if approved, property statements for the financial year 2021-2023 (2021-22 & 2022-23) of Smt. Parul Kumari, Addl. Civil Judge (Junior Div.), Sonbhadra, be laid before Hon'ble Mr. Justice Saurabh Srivastava, Administrative Judge, Sonbhadra Judgeship for His Lordship's kind perusal and orders?
