May kindly see the property statement received online from Sri Mohd. Farhan, Addl. Civil Judge (Junior Div.), Mohammadabad-Ghazipur, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2021-2023 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2021-2023 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2021-2023 (2021-22 & 2022-23), the Gross income from salary is Rs.23,66,510/- and total deductions/savings/investment against NPS, GIS, Insurances, loan repayments including amount paid other than loan, Sukanya Samridhi Yojna Account and Income Tax is Rs.14,26,696/-. Thus, a sum of Rs.9,39,814/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2021-2023 (2021-22 & 2022-23) and the balance of his savings bank account(s) is also decreased by Rs.3,57,652/- in this financial year from previous year's balance.

It is pertinent to mention here that his wife working as Assistant teacher, have annual income of Rs.8,20,440/- (as mentioned by officer).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2019-2021 (2019-20 & 2020-21) online against Case Id : P00045762021 (Old Case Id : 6733) and the same has been processed before Hon'ble Mr. Justice Prakash Padia, Administrative Judge, Ghazipur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2021-2023 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial year 2021-2023 (2021-22 & 2022-23) vide online dated 02.05.2024. As such, there is delay in submitting the same from the part of the officer for which officer has stated in the remark column, that *"I am sending this Declaration of property statement after a considerable delay because I was under the wrongful impression that property statement it is send after two years. But I had wrong information and I had submitted my property statement 2022 to 2024 While I had to submit property statement 2021 -2023 on 31.03.2023 . I am extremely sorry for this. Respected Sir, Please pardon me for this wrongful assumption. It will not happen in future again and accept my property statement by condoning delay."*

May, therefore, if approved, property statements for the financial year 2021-2023 (2021-22 & 2022-23) of Sri Mohd. Farhan, Addl. Civil Judge (Junior Div.), Mohammadabad-Ghazipur, be laid before Hon'ble Mr. Justice Prakash Padia, Administrative Judge, Ghazipur Judgeship for His Lordship's kind perusal and orders?
