

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Sri Ravindra Prasad Gupta, Chief Legal Adviser, Noida, Gautambuddha Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial year 2020-2022 (2020-21 & 2021-22)**, the Gross income is Rs.40,53,768/- (Rs.39,83,109/- from Salary and Rs.70,659/- from Bank Interest) and total deductions/savings/investment against GIS, GPF, PPF, SIP, Insurances, Loans repayments and Income Tax are Rs.26,57,384/- and the balance of his savings bank account(s) is also increased by Rs.7,32,894/- in this financial year from previous year's balance, total of which is Rs.33,90,278/-. Thus, a sum of Rs.6,63,490/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2020-2022 (2020-21 & 2021-22).

It is pertinent to mention here that his wife have monthly income of Rs.1.5 lakh approx. and Rs.1.8-2.00 lakh approx. in the financial year 2020-21 & 2021-22 respectively from Legal Profession.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id : P00022142021 (Old Case Id : 4342) and the same has been seen by Hon'ble Mr. Justice Rohit Ranjan Agarwal, the then Administrative Judge, Gautambuddha Nagar Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has firstly submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 15.05.2024. As such, there is delay in submitting the same from the part of the officer for which he has stated in the remark column, that "*due to excess of work . I could not submit my property statement on time. I unconditional appolige for the same.*"

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Sri Ravindra Prasad Gupta, Chief Legal Adviser, Noida, Gautambuddha Nagar, be laid before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Gautambuddha Nagar Judgeship for His Lordship's kind perusal and orders?
