Thus, a sum of Rs.18,48,421/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2022-2024 (2022-23 & 2023-24).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2020-2022 (2020-21 & 2021-22) online against Case Id: P00061302022 and the same has been seen by Hon'ble Mr. Justice Rohit Ranjan Agarwal, the then Administrative Judge, Firozabad Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2022-2024 (2022-23 & 2023-24) in its next financial year i.e., 2024-25 upto March 2025. He has submitted movable and immovable property statements of the financial year 2022-2024 (2022-23 & 2023-24) vide online dated 02.05.2024. As such, there is no delay in submitting the same.
