

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Sri Shivam Vashisth, Civil Judge (Junior Div.), Musafirkhana-Sultanpur, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2021-2023 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2021-2023 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial year 2021-2023 (2021-22 & 2022-23)**, the Gross income from salary is Rs.25,48,425/- and total deductions/savings/investment against NPS, GIS, PPF, loan repayments and Income Tax is Rs.10,89,710/- and the balance of his savings bank account(s) is also increased by Rs.22,310/- in this financial year from previous year's balance, total of which is Rs.11,12,020/-. Thus, a sum of Rs.14,36,405/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2021-2023 (2021-22 & 2022-23).

It is pertinent to mention here that his wife have annual income of Rs.3.00 lakhs by profession as tutor and also officer & his wife each have Rs. 1 lakhs and Rs.1,50,000/- cash in hand respectively (as mentioned in column 4).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2019-2021 (2019-20 & 2020-21) online against Case Id : P00004782024 and the same has been processed before Hon'ble Mr. Justice Irshad Ali, Administrative Judge, Sultanpur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2021-2023 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial year 2021-2023 (2021-22 & 2022-23) vide online dated 08.05.2024. As such, there is delay in submitting the same from the part of the officer for which officer has stated in the remark column, that he had joined in Nov 2019, so thought and anticipated that the property statement for the financial year 01 April 2020 to 31 March 2022 will be treated as at the date of joining and will be counted for period of two years, since no significant growth in income was done in 4 months i.e from Nov 2019 to March 2020. And therefore due timely submitted 2022 - 2024, which he thinks should be withdrawn and correct statements be filled as per Hon'ble H.C's Objection. With utmost regard and due apology, he would humbly request to consider the matter.

May, therefore, if approved, property statements for the financial year 2021-2023 (2021-22 & 2022-23) of Sri Shivam Vashisth, Civil Judge (Junior Div.), Musafirkhana-Sultanpur, be laid before Hon'ble Mr. Justice Irshad Ali, Administrative Judge, Sultanpur Judgeship for His Lordship's kind perusal and orders?
