May kindly see the online property statement received from Sri Gopal Upadhyay, Additional District & Sessions Judge, Muzaffarnagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2022-23 & 2023-24 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2022-23 & 2023-24 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

1. In the financial years 2022-23 & 2023-24, Total income is Rs.1,29,82,399/- (total Gross income is Rs.1,22,24,604/-, rental income is Rs.1,20,000/- and matured amount of Insurance policies are Rs.6,37,795/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, Income Tax, Insurance policies, PPF a/c, Home loan, Sukanya Samriddhi a/cs, Shares, Mutual Fund and the balance of his savings bank account(s) has also been enhanced for Rs.49,35,944/- in this financial year from previous year's balance, total of which is Rs.1,05,48,672/-. Thus, a sum of Rs.24,33,727/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife is Advocate having annual income near about 5 lac.

In this connection, it is submitted that the officer has already submitted his property statements upto the financial year 2018-20 which has already been seen online by Hon'ble Mr. Justice Pankaj Naqvi, the then Administrative Judge, Shahjahanpur. And online detailed note for the financial year 2020-22 has also been submitted before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Muzaffarnagar Judgeship for His Lordship's kind perusal and orders on eService ID P00060762022.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2022-23 & 2023-24 in its next financial year i.e., 2024-25 upto March,2025. He has submitted movable and immovable property statements of the financial years 2022-23 & 2023-24 firstly vide online dated 18.05.2024. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2022-23 & 2023-24 of Sri Gopal Upadhyay, Additional District & Sessions Judge, Muzaffarnagar be laid before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Muzaffarnagar Judgeship for His Lordship's kind perusal and orders?
