

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Sri Anil Kumar-XI, Chief Judicial Magistrate, Sant Kabir Nagar at Khalilabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2021-23 (2021-22 & 2022-23), Gross income from salary is Rs.36,73,140/- and total deductions/savings/investment against GIS, Income Tax, PPF, LIC, mutual funds and the balance of his savings bank account(s) is also enhanced by Rs.1,76,513/- in this financial year from previous year's balance, total of which is Rs.18,75,312/-. Thus, a sum of Rs.17,97,828/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both of the financial years. It is pertinent to mention here that his wife is having annual income of Rs.2,55,000/- (approx) from business, as mentioned by the officer.

In this connection, it is submitted that the Officer has submitted his property statements upto the financial years 2019-21 online and the same has been processed online against Case Id : P00051832021 before Hon'ble Mr. Justice Shiv Shanker Prasad, Administrative Judge, Sant Kabir Nagar Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. The officer has firstly submitted his movable and immovable property statements for the financial years 2021-23 (2021-22 & 2022-23) vide online dated 23.05.24. As such, there is delay in submitting the same from the part of the officer. In this regard, the officer has stated (in his verbatim) that "I beg to pray that in compliance of Hon'ble High Court's notification no. 549/Admin(Services)/2023 dated April 27, 2023, I have been transferred in annual chain from Saharanpur to district Banda as Chief Judicial Magistrate. Afterthat in compliance of Hon'ble High Court's notification no. 1617/Admin(Services)/2023 dated May 22, 2023, I have been transferred from Banda to Kanpur Nagar as Judge Small Causes Court and afterthat in compliance of Hon'ble High Court's notification no. 2229/Admin(Services)/2023 dated November 18, 2023, I have been transferred from Kanpur Nagar to Sant Kabir Nagar as Chief Judicial Magistrate. Unfortunately, I faced three transfer in a calendar year that is part of financial year 2023-24. My all documents related to property, salary, and investments etc. were in disarray. So, I was not able to furnish the required statement timely. It is my humble request to your goodself to condone the delay. I will be highly obliged for your kindness", as mentioned by the officer.

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 & 2022-23) of Sri Anil Kumar-XI, Chief Judicial Magistrate, Sant Kabir Nagar at Khalilabad be laid before Hon'ble Mr. Justice Shiv Shanker Prasad, Administrative Judge, Sant Kabir Nagar Judgeship for His Lordship's kind perusal and orders?
